

EVENT ATTENDEE WAIVER AND RELEASE OF LIABILITY FORM

COVID-19 Policy

Lifestyle Launch LLC (LL) continues to monitor policy and procedures during the COVID-19 pandemic. The health, safety, and well-being of our Camp Indie camper community (Attendee) as well as the venue (Camp Club Getaway) employees is our top priority.

Therefore, attendees are required to provide proof of full vaccination status.

Or, if you are unvaccinated you must provide proof of a negative PCR test taken within 72 hours of the event as well as submit to an on-site rapid test upon arrival.

If you are unable to take a PCR test prior to arrival we will accept a negative rapid test on site, however, in the spirit of community and safety please get the PCR test before you arrive.

In the event of a positive test result, you will be denied entry into the event and must leave the premises immediately. Lifestyle Launch, LLC and Camp Club Getaway are not responsible for your change in travel plans or anything else related to your positive covid test results and cannot issue a refund.

Attendees who are fully vaccinated against COVID-19 should follow CDC's [Interim Public Health Recommendations for Fully Vaccinated People](#).

People who are not fully vaccinated against COVID-19 should use [prevention](#) strategies, such as wearing masks, physical distancing, hand hygiene, and respiratory etiquette.

Lifestyle Launch LLC has put in place preventative measures to reduce the spread of the COVID-19 virus; however, we nor the venue (Camp Club Getaway), under no circumstances, are able to guarantee that you or a guest will not become infected with the virus while on the premises and in surrounding areas.

Please review the agreement below. Additionally, your signature will be required as a confirmation of your intent and commitment to abide by policies put in place to protect all Camp Indie attendees and staff.

Agreement:

I agree that I will NOT carpool to this event with other attendees unless we are all fully vaccinated and show proof to each other prior to entering the car.

Due to the guidelines around Covid 19 exposure, if one person in a car tests positive for Covid-19, then all individuals in that car will not be allowed into the event and no refunds will be issued, since our policy advises against carpooling unless all individuals are fully vaccinated and can show proof.

- I declare I am not experiencing or exhibiting any COVID-19 related symptoms as outlined by the federal and state Center for Disease Control and Prevention (CDC) such as fever, dry cough, or shortness of breath.
- I acknowledge I must follow the safety protocols that have been implemented by Lifestyle Launch LLC and/or Camp Club Getaway.
- I am not aware nor do I believe I have been recently exposed to a person or animal with a positive and confirmed case of COVID-19.

Activity Participation Agreement

Camp Indie attendee voluntarily assumes all risks and danger incidental to the event for which the ticket is issued. Attendee voluntarily agrees that the management, facility, promoters, attendees, Camp Indie, Lifestyle Launch LLC, and all of their respective agents, officers, directors, owners, and employees are expressly released by attendee from any claims arising from such causes.

Although precautions are taken to provide proper organization, instruction, and equipment for your participation in our programs, there can be no guarantee of absolute safety against injury and unforeseeable accidents. There are elements of risk in any adventure, sport, or program involving physical exertion and risk taking, or associated with the outdoors (referred to herein as "activity"), and the use of any equipment for the activity. I, on behalf of myself, understand that I may be involved in activities including but not limited to meditation, yoga, sports, swimming and/or other physical activities. Some of these activities are rugged adventure recreational activities. I acknowledge that I may decline to participate in any activity. Any participation will be voluntary.

ACKNOWLEDGMENT OF RISKS: I recognize that there is inherent danger in any activity which involves physical exertion or risk taking; that natural hazards do exist; that although the program may not be strenuous, injuries or medical complications may occur; that certain foreseeable and

unforeseeable events unique to each individual activity can contribute to the unpredictability of the activity; that balance and physical coordination may affect the occurrence of accidents or falls; and that I should ask about other potential hazards and recommended precautions and procedures.

EXPRESS ASSUMPTION OF RISK AND RESPONSIBILITY: In recognition of the inherent risks of the activity, which I will be engaged in, I confirm that I am physically and mentally capable of participation in the activity and/or using equipment. I understand that I will be participating willingly and voluntarily and I assume full responsibility for personal injuries, accidents or illnesses, including death. I also assume responsibility for damage to or loss of personal property as the result of any accident that may occur. On behalf of myself I assume the risk(s) of personal injuries, accidents, and/or illnesses, including, but not limited to, sprains, torn muscles and/or ligaments; fractured or broken bones; eye damage; cuts, wounds, scrapes, abrasions, and/or contusions; dehydration; head, neck, and/or spinal injuries; animal or insect bite or attack; injury caused by discharge of any weapon; shock, paralysis, and/or death.

TERMINATION OF ACTIVITY: I recognize that Lifestyle Launch LLC, as provider of services, may find it necessary to terminate any activity due to forces of nature, medical necessities, or other problems; and/or to terminate the participation of any person Lifestyle Launch LLC judges to be incapable of meeting the rigors or requirements of participating in the activity. I accept Lifestyle Launch LLC's right to take such actions for the safety of myself and/or other attendees. I acknowledge that no guarantees have been made with respect to achieving objectives.

AUTHORIZATION: I hereby authorize any medical treatment deemed necessary in the event of any injury to myself while participating in the activity. I will have appropriate insurance or, in its absence, I agree to pay all costs of rescue and/or medical services as may be incurred on behalf of myself.

RELEASE: In consideration of services or property provided, I, for myself, do hereby release Lifestyle Launch LLC, its principals, trustees, directors, officers, agents, employees and volunteers, and each and every land owner, municipal and/or governmental agency upon whose property an activity is conducted, from all liability with respect to myself and I waive any claim for damage arising from any cause whatsoever, except for any claims which are the result of gross negligence of the party or parties released herein. I expressly understand and agree that neither Lifestyle Launch LLC nor any of its officers, agents, assistants, or employees shall be held responsible or made subject, to any claim seeking to assess damages of liability for or arising from personal injury or property damage or loss of any sort, to myself or any other person on whose behalf this agreement is now signed as a result of actual or proposed participation in Camp Indie. I also hereby agree to indemnify Lifestyle Launch LLC, its officers, agents, assistants, or employees harmless on account of any such claims.

Management reserves the right, without refund of any portion of the ticket purchase price, to refuse admission to or eject any person whose conduct is deemed by management to be

disorderly, who uses vulgar or abusive language or who fails to comply with these or other management rules. Breach of any of the foregoing will automatically terminate this license. NO REFUNDS. NO EXCHANGES EXCEPT AS PROVIDED HEREIN. EVENT DATE & TIME SUBJECT TO CHANGE. ALL RIGHTS RESERVED.

PHOTOGRAPHY: I authorize Lifestyle Launch LLC the right to take and use any photographs, slides and videos of camp and myself for promotional purposes; for any lawful purpose, including but not limited to publicity and Web content. Attendee acknowledges that the event may be broadcast, recorded, or otherwise publicized, and hereby grants permission to utilize the holder's image or likeness in connection with any live or recorded transmission or reproduction of such event.

As an attendee you are entering into an agreement with Lifestyle Launch LLC for creative commons and understand that your image may be utilized by Lifestyle Launch LLC for marketing and promotional materials.

To the fullest extent permitted by law, I hereby agree to waive, release, and discharge any and all claims, causes of action, damages, and rights of any kind, including serious injury or death, against Camp Indie and Lifestyle Launch, LLC, its insurers, and all of their respective employees, agents, representatives, and volunteers (the "Released Parties") arising from or relating in any way to my participation in camp. Including but not limited to exposure to the COVID-19 virus as we are assuming that risk.

Signature:

By signing this event attendee waiver and release of liability form, I acknowledge the contagious and evolving nature of COVID-19 and voluntarily assume the risk that I may be exposed to the virus and become infected as a result. I understand the risk of becoming infected may impact members of the community, event guests, and event attendee's families or personal contacts.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any expense, liability, illness, injury, disability or death related to contracting the virus while attending an event hosted at Camp Club Getaway by Lifestyle Launch LLC. I hereby release, covenant not to sue, discharge, and hold harmless Lifestyle Launch LLC from all claims of any kind arising out of COVID-19. I understand and agree that release of liability includes any claims towards Lifestyle Launch LLC, Camp Club Getaway, representatives, employees and attendees whether a COVID-19 infection occurrence exists before, during, or after attendance and participation at the Camp Indie event.

This event attendee waiver and release of liability form shall be governed by and construed under the laws of the State of Connecticut, without regard to its choice of law principles. I agree not to commence or prosecute any action in connection herewith other than in the state and/or federal courts of the State of Connecticut.
